Privacy Policy

BodyMetics Privacy Obligations:

BodyMetics ABN 78 759 669 783 will comply with the National Privacy Principles outlined in the *Privacy Act of* 1988 (Cth) relevant to the collection, use, disclosure, storage and protection of personal information.

What personal information BodyMetics collect?

BodyMetics will only collect client personal information directly and obtained from when a client visits the clinic or upon entering the client's personal details from the website. The website will receive personal information from the client such as name, home and email address, home phone number and mobile number. Other personal information such as birthday, gender, occupation, medical history, health fund provider details and payment details are collected during the initial consultation. All personal information is considered private and strictly confidential by BodyMetics. BodyMetics collects and hold personal information from a client who communicate with BodyMetics directly either by phone call, completion of a consultation form or feedback form via email or through the website portal.

Personal information means information or an opinion about an identified individual, or an individual who is reasonably identifiable (whether true or not and whether recorded in a material form or not).

What BodyMetics use client's personal information for?

Information BodyMetics collect about the client is to understand the requirements or needs so that the massage treatment achieves a successful outcome for the client. Personal information of the client will not be disclosed to anyone without the client's permission. Unless the disclosure is required or authorised by law, including without limitation the National Privacy Principles under the *Privacy Act 1988 (Cth)* (as replaced by the Australian Privacy Principles from 12 March 2014).

Who do BodyMetics disclose client's personal information to?

BodyMetics may disclose personal information of a client to a health fund provider for providing health fund rebates and health professionals such as a general practitioner when a client requires diagnosis and opinion beyond the scope of BodyMetics massage practice. BodyMetics may also disclose personal information to statutory bodies such as the police for the purpose of conducting ethics or complaints enquiries.

Marketing Promotion

Client's personal information may also be used (with permission) for promotional purposes by BodyMetics. If the client does not wish to receive any promotional marketing information, personal information is removed from the marketing list. Deletion or removal of personal information is done by contacting BodyMetics on 0426 125 001 or email info@bodymetics.com.au. BodyMetics will not disclose any of the personal information of a client to any

other person or organisation unless the disclosure is required by law or is otherwise permitted by the National Privacy Principles (as replaced by the Australian Privacy Principles from 12 March 2014).

A client is entitled to access personal information that BodyMetics holds about the client. A request to access the client's own personal information can be granted unless providing the client with access would unreasonably impact the privacy of others or where BodyMetics is permitted not to provide access by law, including the National Privacy Principles (as replaced by the Australian Privacy Principles from 12 March 2014). If BodyMetics refuses to grant access to the client's personal information, the client will be provided with the reason(s) for the refusal.

How do BodyMetics ensure the personal information of the client is secure and up to date?

BodyMetics will ensure the safety and security of all client's personal information. All information collected either directly from the client or the website will be held on the computer system of BodyMetics. The hard copy is stored securely on the premise and is only disclosed or used for the purposes described in this Privacy Policy. BodyMetics does not collect sensitive or financial information about the client through the website.

If BodyMetics has no further need for the client's personal information, this will be deleted from the system and all records relating to the client is removed.
